There is still a need to do further research to answer the question as to whether or not the mixed service period creates a significant harm to E911. This will be done with the ongoing assistance of NENA who participated in the April WG meeting. It was also requested of NENA that they, with the assistance of the LNPA WG where necessary, develop a standardized process that would document the responsibilities of both the old and the new service provider in the occurrence of a wireline to wireless port.

This would involve the old service provider performing the "unlock" transaction and the new service provider performing the "migrate" transaction within this 24 hour period. This will resolve the issue of 9-1-1 updates not happening concurrently or delays between the unlock and migrate.

\par NENA also requested that the End User Move Indicator (EUMI) on the LSR be made a required field. This would also pertain to the pre-order requirements document used between a reseller and network service provider. This will resolve the issue of the old service provider knowing when to perform a "delete" transaction as opposed to the "unlock" transaction when the end user is actually changing location during porting. Process and system changes will be required by service providers in differentiating the delete and unlock transactions based on entry in the EUMI field.
